#### 2.3.1

#### **Response:**

The entire process of the college is student-centric and focused on their overall development. All stakeholders of the college are well aware of the aspirations of the students because most of the students are from rural backgrounds. Apart from the 'Chalk and Talk' or 'Lecture Delivery' method, teachers are more focused on the 'conceptual clarity' of their subject.

Classrooms are well-equipped with LCD projectors and screens. The college issued separate PC to each department. The college has a Wi-Fi unit for the students inside the campus. Further, it has a computer lab with an internal LAN. Broadband Leased Line Internet connection is highly useful to function all the above devices very speedily. All staff is well familiar with all the latest ICT tools. To strengthen their knowledge, IT Dept. guides college faculties on how to create Personal Blogs',

#### **Methods of teaching:**

**Experiential Learning –** 

Learning that is considered "experiential" contains all the following elements: reflection, critical analysis, and synthesis, and opportunities for students to take initiative, make decisions, and be accountable for the results. It provides opportunities for students to engage intellectually, creatively, emotionally, socially, or physically.

- Encourages students to get an experience of what they are exactly Studying in the books.
- Simultaneously, the Dept. of Commerce visited Lasur Market Committee in order to understand the actual working of the market.
- Digital library, provision of e-books, e-journals through INFLIBNET. Provision of computers, L.C.D., internet 300 Mbps downloading and 30 Mbps uploading speed & Wi-Fi facility up to certain limit
- Besides this workshop, elocution competitions, debate competitions, and mentoring programs are taken.

Participative Learning seminars, group discussions, wallpapers, poster presentations, and projects. Dept. of Marathi conducts 'Language Fortnight' on the occasion of National Marathi Language Day. The students of these departments do visit nearby banks, industries, and villages to understand and experience bank transactions, micro-finance groups, land measurement, etc. Students are encouraged to ask questions and share their thoughts in class and are assessed by Peer Learning. A health survey is done at Siresaygaon village. The socio-economic survey is also performed at Rahegaon village. Besides this teaching discussion, the Interactive, communicative method is followed.

**Problem-Solving Method** —While teaching in the class, students participate in the learning process and experience those things in his/her practical, fieldwork. All faculties encourage students to lead their learning towards solving their problems and satisfaction. For this, the college organizes expert lectures on share marketing and retail marketing. All such activities, visits, and role-playing help them to pacify the curiosity of their problem raised while learning in the class

Similarly, Computer Science departments effectively mix up theoretical classroom teaching and practical exposure through youtube videos. Social media is skillfully used by the college through its Whatsapp group, Facebook, Twitter, and accounts and all these links are visible on the front page of the website. College Facebook and youtube page is widely used to attend guest lecture, workshops, etc. Each teacher has created a list of the subject-related topics from YouTube\_to\_students.

#### 2.5 Evaluation Process and Reforms

#### 2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time-bound and efficient

#### **Response:**

The college consistently works on student-centric activities. Evaluation is an integral part of the teaching-learning process. With regular interactions between IQAC and the Heads of the department, the examination committee plan and work out reforms in the evaluation system. The college adjusts the academic calendar by including internal assessments and university examinations. The institutional

internal evaluation system is decentralized in order to make it more transparent and objective.

Apart from university-prescribed methods like assignments and tutorials, the college conducts internal tests with more relevant methods as per the academic calendar, tentative schedule is prepared and displayed on the notice board and on the WhatsApp group of the classes. The examination committee monitors and conducts internal examinations in the college. All the teachers submit the question papers to the examination committee.

Unit tests/tutorials are conducted periodically. The assessment work is carried out by the concerned subject faculty in the institution. The evaluation reports are prepared within the stipulated time and communicated to the students in the classroom as well as displayed on the notice board. There is at least one internal test per semester. All exam-related grievances are addressed to the committee where the Principal is the chairperson.

However, internal supervisors and the internal flying squad are deputed for the smooth conduction of the exams. If any grievance occurs, he/she needs to apply to the exam committee. Internal exam marks of the student are displayed on the notice board and queries are discussed with them till they satisfy. Each teacher prepares question papers by keeping in mind the ethical values of the institute and academic integrity. Interestingly, internal assessment is carried out in actual teaching in the class in a play way situation by asking questions.

There is little space for mechanisms to deal with examination-related grievances for the institution. The institutional reforms in the continuous evaluation system are related to creating interest in the study and making the students more familiar with the university examination pattern. The institutional measures used for the evaluation are to direct and lead the students confidently toward university examinations. Hence there is very little scope for grievances regarding evaluation. The students have the freedom to use the suggestion box to put in the note of query/instruction which is considered for internal examination reform.

#### The Practice:

In order to make students understand the importance of cleanliness dustbins for solid waste and liquid waste have been kept in the college. The mulch collected from the trees at the college is used in a vermicomposting project and the compost produced is fed back to the trees. In order to make the students aware of the importance of water conservation, rainwater harvesting has been installed in the college to drain water from the roof to the ground. all the electrical appliances in the college have been fitted with energy savers so that the students know the importance of saving energy. College staff instructing students to use dustbins to dispose of waste. National Service Scheme volunteers and college staff dispose of the waste collected in the college in the vermicomposting project. The importance of saving water is communicated to the students through various slogans on the college premises. Solar Panel has been installed in the college campus to save electricity. Canteen Plastic waste is given to Gram Panchayat Garbage Vehicle.\

#### **Evidence Of Success:**

The students became aware of the importance of cleanliness by using dustbins on college premises and also practiced it through NSS. Garbage bins were placed in the college premises. As a vermin-composting project was started on the college premises, the students learned about the benefits of vermin-composting in agriculture. By installing rainwater harvesting on the college premises the students realized the importance of saving water. By installing solar panels and LED bulbs in the college campus the students realized the importance of saving energy.

#### Problems encountered and resources required:

More importance should be given to the students regarding the use of waste beans, more tree plantations are needed to feed the compost produced in the vermicomposting plant and packaging is needed to sell the vermicompost, a greater number of rainwaters harvesting pipes are needed to drain water into the ground. More LED bulbs and solar panels are needed in the college premises.

#### Resource required: -

- Being a self-financed college more fund is required to buy resources and to conduct awareness initiative towards Water, Energy, vermin compost management, and conservation.
- Packaging and sale of vermicompost should be done.
- More rainwater harvesting pipes should be installed to drain roof water to the ground.
- More LED bulbs and solar panels should be installed to save energy
